TECHNO HORIZON CO., LTD.(hereinafter "the Company") announces that at the board of director's meeting held today, we have resolved to close "ELMO Europe SAS Middle East (Branch)" (hereinafter "ESAS Dubai Branch") which is Dubai branch of ELMO Europe SAS, an overseas subsidiary of our consolidated subsidiary and transfer their business to ESCO Pte. Ltd. (hereinafter "ESCO") and open the same branch as "ESCO Pte Ltd Branch" (hereinafter "ESCO Dubai Branch"), as follows.

1. Purpose of Business Transfer

On October 2015, ESAS Dubai Branch was opened as a representative office in Dubai, United Arab Emirates (UAE). It has contributed to the development of education to strengthen marketing in the Middle East region through the support of regional distributors and the sale of educational system equipment such as document cameras.

By transferring operations in the Middle East region which were previously handled by the ESAS Dubai branch to ESCO which has established its own network with bases throughout Asia as our group company, we can centralize base management and improve efficiency. In this way, we decided that we can strengthen our business.
